Mumbai April 29, 2016: Anil Ambani, Chairman Reliance Group called on the President of Ukraine Petro Poroshenko on 28 April in Ukraine. During an hour long meeting, the two leaders discussed issues of strategic interest between the Indian and Ukrainian Defence and Aerospace Industry.

As a follow up of the meeting, a Strategic Partnership Agreement was signed between State Owned Ukroboronprom of Ukraine and Reliance Defence, which will allow it to collaborate with Antonov for its range of military and commercial transport aircraft.

Reliance Defence Ltd is a wholly owned subsidiary of Reliance Infrastructure Ltd.

Under the agreement, Reliance and Antonov will jointly bid for the Medium Military Transport Aircraft program of the HAL. In addition to this, the two companies will also collaborate for assembly, manufacture and maintenance, repair and overhaul (MRO) of Antonov series of aircraft to address the requirements of the Indian market and also the agreed Global markets.

Cooperation will also cover upgrades for the BMP 2 and Armored Vehicles, Unmanned Aerial Vehicles and Marine Gas Turbines for the Indian Navy Frigate program.

It is understood that HAL is looking at a market size of up to 300 aircraft in the medium range. This will be potentially the largest collaborative effort involving the Public Sector, Private Sector and Global OEM as part of the Make in India and Skill India initiatives of the Government with value of programs exceeding Rs 50,000 crore.
