Dear Shareholder, pursuant to the directions issued by the Investor Education and Protection Fund Authority (IEPFA), vide Circular dated July 16, 2025, "Saksham Niveshak - 100 Days Campaign" has been initiated by Ministry of Corporate Affairs from July 28, 2025 to November 06, 2025 with the objective to facilitate shareholders to update their KYC details such as Email ID, PAN, bank mandate, nomination, Specimen signature and contact information (postal address, mobile number) etc.

As a part of this campaign, Reliance Infrastructure Limited (the 'Company') has also initiated steps to facilitate its shareholders to update their KYC and other details with the Company's Registrar and Transfer Agent (RTA), i.e. KFin Technologies Limited.

The shareholders are also encouraged to claim their unpaid / unclaimed dividends in order to safeguard their entitlements and prevent transfer of such dividends and the underlying shares to the IEPFA, in accordance with applicable statutory provisions.

Shareholders are kindly requested to take note of the above instructions and act accordingly and **submit the requisite documents by November 06, 2025.**

Shareholder may also note that, pursuant to Circular No. SEBI/HO/MIRSD/MIRSD-PoD/P/CIR/2025/97 dated July 02, 2025, a one time Special Window has been opened for a period upto January 6, 2026 providing an opportunity for the shareholders to re-lodge the transfer deeds which were lodged prior to April 1, 2019, and were rejected/returned/not attended to due to deficiency in the documents/process/or otherwise. Eligible shareholders who wish to avail this opportunity, may submit the transfer request along with requisite documents to the Company's RTA.
