Sub: Disclosure under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations")

Pursuant to Regulation 30 of the Listing Regulations, read with SEBI Circular No. SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024, it is hereby informed that today the Company secured a favourable arbitral award dated August 12, 2025 ("Award") passed by an arbitral tribunal in an arbitration invoked by the Company against M/s. Aravali Power Company Private Limited ("APCPL") in relation to an EPC Contract ("Contract").

A three-member arbitral tribunal by a majority award has held that the termination by APCPL was illegal, invalid and wrongful and partly allowed the Company's claims towards damages and costs incurred due to wrongful termination. The Award in favour of the Company is for a sum of **Rs. 526.23** crore along with interest.

We enclosed herewith a copy of the Media Release being issued by the Company which is self-explanatory, as Annexure- A to this letter.
