- 3. It is also submitted the proper course for closure of CIRP in the present case would be Section *12A* of the IBC, *per* para *82* of the Byju's judgment.
- 4. The Reply be filed within four weeks from today. Rejoinder, if any, be filed within a week thereafter.
- 5. Admittedly, the impugned order was suspended *vide* our order dated 04.06.2025. Considering the submissions that the amount as was claimed in
