a) **Data Centre Sector**

Gramercy is envisioned as a next-generation hub for digital infrastructure, where uninterrupted, high-quality power is critical to the 24x7 operations of data centres. Even brief outages or voltage fluctuations can cause major disruptions and financial losses. Distribution Licensee status will enable Gramercy to directly manage power supply and ensure the reliability these facilities demand.

b) As a Distribution Licensee, Gramercy can minimize power procurement costs, reduce losses, and avoid unnecessary surcharges, leading to significant savings for consumers. d) At present the Proposed Licence Area is being served by Maharashtra state Electricity Distribution Company Limited (MSEDCL). If Distribution Licence is granted to Gramercy, Gramercy will be the second Distribution Licensee in the identified area of supply.

c) The company has built a state-of-the-art, fully underground power distribution network with SCADA-based systems, ensuring power availability exceeding 99.99%.
